 - c. School Liaison Report- None present at this meeting.

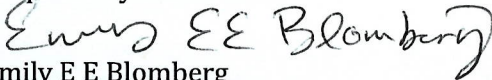
DISCUSS & POSSIBLY TAKE ACTION

Motion Palmquist, second Pierson to accept all the nominations. Carried
2. Consider Continuing 3k Services (Franz) She is willing to go back to the school and get the 3K license. Calhoun held that license so we did have this program under her. Motion Erickson, second Pierson to continue the beyond 3K services which allows Franz to go back to school to get the license. This will fall under our new policy of reimbursement of licenses for teachers.
